British Columbia: salary disclosure on position postings

British Columbia's Pay Transparency Act came into force on November 1. All job postings must now indicate the salary or salary range offered. The aim is to reduce wage discrimination and offer greater transparency.

In Ontario, pay transparency legislation has been in force since 2018.

Quebec has yet to impose any measures. A trend is emerging nationwide to improve pay equity.
